

### **ROMANIAN TRADE AND INDUSTRY**

For more than a decade, Bucharest has been the top FDI destination in the nation. But there is interest in other areas as well, especially the western portion of Romania, where cities like Cluj-Napoca, Timisoara, and Oradea are luring a sizable amount of investment. Additionally, Romania is strategically located in the vicinity of several large markets. The setting of the Ukrainian conflict made it clear that the globe needed its gas resources in order to be independent of Russian supplies. Among the EU member states, Romania has the highest level of energy independence. Therefore, foreign investors' interest in Romania increased.

Romania's economy is a high-income mixed economy with a skilled labor force and a very high Human Development Index; it is ranked 10th in the European Union by nominal total GDP and 7th when adjusted for purchasing power parity. For foreign direct investment, Romania ranks first in Central and Eastern Europe. They are also the biggest producer of electronics in Central and Eastern Europe. They have developed over the past 20 years into a significant hub for research into associated hardware, information security, and mobile technologies. In industries like IT and auto manufacturing, the nation dominates the region. One of the major economic and industrial hubs in Eastern Europe is Bucharest. Vehicles, machinery, chemical products, electronics, electrical equipment, pharmaceuticals, transport equipment, basic metals, food items, rubber, and plastics are Romania's top 10 exports.

In the first quarter of 2022, Romania's GDP expanded by 6.5 percent year over year, picking up speed from the previous quarter's rise of 2.4 percent. A preliminary assessment indicates that despite lowering COVID-19 measures and weak base effects from the previous year, it was the fourth consecutive quarter of GDP growth. The economy expanded by 5.2 percent on a quarterly basis, the fastest rate since the fourth quarter of 2020, following a revised 1% expansion in the fourth quarter of 2021.

Geographical Location: Romania is located in Southeastern Europe. The country is bordered to the north by Ukraine, Moldova to the northeast, the Black Sea to the southeast, Bulgaria to the south, Serbia to the southwest, and Hungary to the west.

Climate: Romania's climate is transitional between temperate and continental, meaning the four seasons are present. It experiences hot summers, cool, dry autumns, cold winters, with snow and fog and mild springs.

### FINANCIAL DISTRICT

Romania's financial district is located in the heart of the historic district of the capital of Romania. As foreign investment decreased in the 1990s, the initial enthusiasm following the revolution in 1989 diminished. At different points during this time, Romania's financial stability was in danger from high inflation. The Romanian leu was evaluated in 2005 in an effort to reduce the inflation rate. The National Bank of Romania, established in 1880, administers the Ministry of Finance's monetary policy by issuing currency and managing budgetary cash resources. In 1995, the Bucharest Stock Exchange opened and began trading hundreds of businesses by 1999. In 1998, Romania had a large number of banks, including international, national, and joint-owned companies.

Today, 34 commercial banks are now operating in Romania, with significant foreign ownership. Non-residents possess more than 70% of the assets in the whole banking sector. Around 90% of the assets in the banking industry are held by commercial banks, which are primarily privately owned. The banking industry in Romania is competitive, with the biggest bank having less than 20% of assets and the next three holding only 40%. A competitive market structure and low level of concentration are shown by the HHI index of concentration's low value of 9%.

### **TOP 3 TOURISM DESTINATIONS**



Transylvania is widely known as the land of vampires

One of Romania's natural borders is the Black Sea, which is also a significant tourist destination and the busiest and most well-liked summer vacation spot for Romanians. In the seventh century BC, the Greeks were the first to seize the opportunity to settle this land, which was soon followed by the Roman Empire. The Black Sea coast is inextricably linked to Dobrogea, which had a strategic location on the ancient map of Europe. It was the main commercial route that connected the Black Sea and the Northern Sea, as well as the Mediterranean ports and the eastern part of the continent



- Romania is derived from the Latin word 'Romanus' which means 'Citizen of the Roman Empire.' Before rumân was interchangeable with roman, rumân was later defined as 'bondsman.'
- There are legends surrounding the origins of Romania's capital, Bucharest. According to one of these legends, a young woman by the name of Dambovita turned down the love of a prince in order to live with a shepherd by the name of Bucur in a place known as Bucaresti. Bucharest was first mentioned in a document signed by Vlad IV dated September 20, 1459. It was an order to build a fortress as a defense against the Turks and conserve a trade route between Brasov and Danubio. Thus, Vlad IV is regarded as the founder of Bucharest.
- Cărturești Carusel is translated as the 'Carousel of Light.' It is a 19th-century architecture in the heart of Bucharest, Old Town. The building was originally built as a bank headquarters for the Chrissoveloni family in the early 20th century. However, it was abandoned when communism collapsed in the 80s. It was then reclaimed by Jean Chrissoveloni in the early 1990s. He invested over one million euros to renovate the former bank to its former glory. It was then leased to Romania's largest bookstore chain, Cărturești. The bookstore opened to the public in 2015, housing almost ten thousand books and a bistro. It is a unique piece of history that became a beacon attracting readers from around the world.

#### THE PAINTED MONASTERIES OF BUCOVINA

There are 8 Painted Churches that were built between 1487 and 1583. All 8 churches have been listed as a UNESCO World Heritage Site since 1993. Stephen the Great built the first monastery in the region of Bukovina. He built approximately 40 churches, many of which were dedicated to commemorating his victories over the Ottoman Empire. The idea for painting the monasteries was his son's, Petru Rares. The Painted Monasteries of Bucovina are the center of Romanian orthodox life. It is regarded as a genuine masterpiece of Byzantine art. Voronet is unquestionably the most stunning of Bucovina's Painted Monasteries.

Interview with the Ambassador of Romania to the Philippines

### H.E. Răduța Dana Matache

Since first arriving in the Philippines to take up your post and the Philippines support each other in multilateral as Romanian Ambassador, how have you observed the institutions and join forces in promoting joint projects. relations between Romania and the Philippines develop The good diplomacy that the Philippines has is definitely and progress? an asset for the country.

My arrival to Manila, in December 2021, was the expression of the decision by the Romanian authorities to upgrade the Embassy, by appointing an Ambassador and expanding the Embassy staff. It was also a recognition that the importance of the Philippines is increasing, regionally and internationally. The fact that my arrival fortunately coincided with a lifting of the strict lockdown was just a bonus.

Part of the Embassy's main mandate was to contribute to the celebration of 50 years of diplomatic relations, in 2022. Indeed, on 28 February 1972, the Philippines and Romania established diplomatic relations, the first time Manila opened relations with a country in the then Communist bloc, across the Iron Curtain of the time.

In this anniversary year, I have noticed a lot of Romania's friends and former business partners come to the fore and express their openness to launching new cooperation projects, benefitting from the experience that they have in dealing with Romania. Also, there is renewed interest in Romania in finding Filipino partners and launching new partnerships.

My conclusion is that there is clearly a momentum for the bilateral relations to flourish again, to the benefit of each of our citizens. We, at the Embassy, are doing our utmost to make sure that we use this momentum to the full.

For a long time, the Philippines has carved for itself the profile of a dependable member of the international community, a pillar of many multilateral institutions, a defender of the rules-based international order and a country with excellent diplomats.

Romanian businesses and people alike appreciate working with the Filipinos. Romanians and Filipinos have a similar outlook on life and a shared sense of humour. They are hardworking and value their first support network, the family. ### The good diplomacy that the Philippines has is definitely an asset for the country.

The Philippines has many assets to speak of: the amazing resilience of its people, their youth, character and determination, the OFWs acting as ambassadors for their country abroad, the beauty of the country's natural environment and the list could go on and on. Therefore it is important how the administration creates the framework in which all the many assets the Philippines has are able to act in unity and coordination to develop the country.

On a personal note, I deeply appreciate the amazing richness of the Filipino people: its celebrated diversity, its multilingualism, its rich cultural heritage, the tolerance, and its unity in diversity.

As far as ASEAN is concerned, the organisation is an old EU partner. This December we shall celebrate 45 years of EU-ASEAN dialogue and cooperation. Both the EU and ASEAN have enlarged and changed in the last 45 years, so we can say that we grew together and have learnt to face new challenges together. The EU-ASEAN dialogue now encompasses all areas of cooperation, including security. It is a dialogue we value, one of the pillars of the EU's Indo-Pacific Strategy. The Philippines, a founding member of ASEAN, currently coordinates the EU-ASEAN dialogue. The EU counts on the Philippines' coordination and facilitation skills, in order to ensure the success of the EU-ASEAN Summit later this year.

### What do Romanian businesses find most attractive about doing business with the Philippines? How do you think both partners can work better together to achieve this vision?

to financing allowing them to survive and thrive in a new environment. Production at some of the best Romanian medicine companies was increased virtually overnight. The Government, supported by the Parliament, quickly put in place legislation to provide for work-from-home whenever this was deemed necessary and possible.

While the first lockdown in Romania was very strict, afterwards the Government showed great flexibility in order to prevent the economy from getting into a standstill. The economy survived COVID-19 and in 2021, production was already back to pre-pandemic levels.

At the same time, like everywhere, businesses made sacrifices, when they had the room of manoeuvre.

One of the reasons why I appreciate the work of the European Chamber of Commerce of the Philippines is precisely the fact that ECCP is a wonderful forum helping us to learn from each other how to build business resilience. If there is a universal recipe for building business resilience I do not know it but I am sure that we can learn from each other, cooperate more and discover the answer.

### How did the pandemic affect trade relations between Romania and the Philippines?

Bilateral trade relations were affected all over the world. Trade between Romania and the Philippines before the pandemic was on a very encouraging upward trajectory. Actually, 2019 was the very best year in our commercial exchanges ever. Bilateral trade declined sharply in 2020 and began to recover in 2021 and we estimate it will surpass pre-pandemic levels in 2022. Luckily, the trade in services was not affected. We hope that 2022 will set a new record, as business exchanges have accelerated.

### What was the biggest hurdle of the embassy during the pandemic, and how was it addressed? of inspiration for the ASEAN countries. I am convinced that we, too, can learn from the experience of the ASEAN

The Romanian embassy, like any other embassy in Manila, went through the motions of getting used to the new normal, of having travel curtailed, of meeting virtually with friends and partners. The pandemic effects' revolutionized the way we work, because work we must. Digitalisation, already under way, took great strides. A challenge for us was the evacuation of tourists but, in this respect, I understand that cooperation both with the Philippines authorities and among EU member-states was exemplary.

How did the COVID-19 pandemic affect the energy industry? What plans does the EU undertake to move forward in reaching the post-pandemic world? How does Romania expect to expedite its decarbonisation

### gas from its former target? What are the challenges that you foresee? How will it impact Romania's energy transformation?


According to our assessments, the pandemic affected less the energy industry than the Russian aggression against Ukraine. The pandemic, at least in countries like mine, allowed for some energy savings. It also led to the disruption of navigation routes, which impeded transport of fossil fuels. However, Romania, like the whole of the EU, has begun a transition towards green and renewable energy long before the pandemic. Over 20% of Romania's energy consumption comes from hydroelectric power plants. They were not affected by the pandemic. Also, over 18% of Romania's energy is generated by our CANDU technology nuclear plant at Cernavodă. This was also not affected by the pandemic. We have our own gas production on-shore and this year the off-shore exploitation of gas in the Black Sea began, with perspectives of further developing in the next years. Romania is the second largest gas producing country in the EU.

So, we were shielded to some extent by the effects of the pandemic on energy. All the while, we have continued our investment in the internal production of energy, especially solar and wind-generated, in order to reach our goal of 30,7% of renewable energy in our energy mix by 2030. We are also developing a national Hydrogen strategy, part of our efforts to achieve the decarbonisation objectives.

## The European Union has long been committed to transitioning to secure, sustainable, competitive, and affordable energy. Are there efforts concluded by the EU possible in being applied to ASEAN countries?

I am sure that our efforts at the EU level can be a source of inspiration for the ASEAN countries. I am convinced that we, too, can learn from the experience of the ASEAN countries and can offer them partnerships as our common challenges can only be faced together. The EU-Philippines Summit this year will celebrate our joint achievements in the past 45 years of dialogue and cooperation but will also look at new ways of working together and finding solutions to challenges, including in the energy sector.





Interview with Department of Energy Secretary

### Hon. Raphael P.M. Lotilla



What is the current state of, and the Department's priority programs, initiatives, and targets for the Philippine energy sector? The attainment of long-term energy security is the primary concern of the Marcos Jr. administration. While the government has been adopting the technology-neutral compared in pursuit of energy security and etchility.

The attainment of long-term energy security is the primary concern of the Marcos Jr. administration. While the government has been adopting the technology-neutral approach in pursuit of energy supply security and stability, efforts have been exerted toward the attainment of a more sustainable and gradual transition to a cleaner energy future.

As such, the Department of Energy (DOE) has formulated a roadmap towards clean energy and a low-carbon future as presented in the latest Philippine Energy Plan (PEP) 2020-2040. Under the Plan, the Clean Energy Scenario (CES) takes the lead in establishing transformational plans, policies, and targets on renewable energy, natural gas, alternative fuels, and energy-efficient technologies.

Meanwhile, as a short-term measure, the DOE is also preparing action plans for 2022-2024 focusing on eight (8) priority areas to ensure supply security and stability. These are (1) codification of upstream energy policies, (2) accelerated renewable energy development, (3) development of the liquefied natural gas industry as a transition fuel, (4) implementation of energy efficiency and conservation, (5) development and utilization of electric vehicles, (6) digitization of energy services i.e., Energy Virtual One Stop Shop System (EVOSS), price monitoring, smart homes, and smart grid, (7) research and development on other energy technologies, and (8) review of relevant energy policies.

What are the trends (on energy, technology, sustainability, etc.) that energy stakeholders should now consider in implementing and developing policies and innovations in the energy sector?

The country continues to utilize a significant amount of fossil fuels such as coal, oil, and natural gas. This accounts for 77.2 percent of the total energy supply with coal making up the largest portion at 37.1 percent, followed by imported oil at 34.6 percent, and natural gas at 5.5 percent. The aggregate share of renewables accounts for 22.8 percent with contributions mainly coming from wind, solar, and biomass energy at 16.5 percent and 4.5 percent from hydro.

The on-grid power generating capacity of the country meanwhile recorded at 27,044 MW as of June 2022. Coal power plants and renewable-based power plants remain a significant part of the country's power-generating supply. Dependable capacity on the other hand totaled 24,112 MW for the same period. In terms of power generation, more than half, or 58 percent was supplied by coal. Renewables followed contributing 22 percent to the total generation.

Considering the current energy sources to meet the required supply, there remains a need to further diversify In the power sector, while the pandemic has greatly our sources as this is critical in ensuring energy supply impacted the construction of generation and transmission security in the long term. Recognizing that supply security projects, related activities to put up these projects have will assist countryside development, the Department is resumed. However, the original target schedule for the working on other supply options that include nuclear, completion and commissioning dates was adjusted, offshore wind, and the development of domestic natural consequently affecting the supply target. Moreover, efforts to expand electricity access continued in response to the gas supply. country's total electrification goal.

Based on the study initiated by the World Bank, the Philippines has a total technical potential of 178 GW of offshore wind energy within 200 kilometers of the shoreline. The excellent areas for floating-type wind turbine generators are north of Luzon, off the coast of north and south Mindoro Island, and the Manila area which is near the demand area. The Guimaras Strait is found suitable for fixed-foundation wind turbine generators.

In fact, the Philippines launched its offshore wind roadmap on 22 April 2022 which lays down the framework for future offshore wind development in the country. It also provides a strategic analysis of the offshore wind development potential in the Philippines, covering the assessment of a wide range of environmental, social, and technical constraints to identify six (6) potential offshore wind development zones with lower environmental and social impacts associated with the development of offshore wind within these zones.

The DOE, through the issuance of Department Circular No DC2019-08-0012 also recognized the advantages of Energy Storage Systems (ESS) as an emerging technology in enhancing the electric power system and in keeping with the goal of assuring the quality, reliability, security, and affordability of electricity supply.

In terms of nuclear energy, the DOE continues to explore its feasibility in supporting the country's sustainable growth by collaborating with various stakeholders to address the requirements of the International Atomic Energy Agency (IAEA).

Along this line, the DOE is re-examining the government's strategy towards building nuclear power plants and exploring the possibility of developing small-scale modular nuclear power plants or their derivatives, subject to compliance with safety standards and regulations of IAEA. As Chair of the Nuclear Energy Program Inter-Agency Committee (NEPIAC), the DOE will convene the Inter-Agency Committee to develop an updated roadmap on using nuclear energy for power generation, covering both conventional and small modular reactor (SMR).

### The COVID-19 pandemic and the Russia-Ukraine crisis, among other recent global phenomena have recently affected world economies and industries. How have such scenarios and how will other current trends shape the future of the energy sector?

At the onset of the COVID-19 pandemic, the daily operations this year, the DOE has awarded a total of 998 RE contracts in the energy sector were affected. Some energy programs and projects were halted or delayed due to strict lockdowns and movement restrictions, supply chain disruptions, and manpower issues. Amidst these challenges, the DOE remained steadfast in assisting in the government's mitigation and response efforts while maintaining reliable and sufficient energy services to the public. Primarily, the DOE has issued pertinent policies and advisories to ensure the continuous delivery of energy goods and services and protect energy consumers.

To ensure continuous operations, the DOE has also prepared its Public Service Continuity Plan (PSCP), which provides operational actions and protocols to be undertaken in response to the COVID-19 pandemic and any related incidents.

Meanwhile, the development of indigenous energy resources, maintaining supply security and overseeing and administering the processing of all contracts, permits, certifications, and endorsements for the upstream, downstream, and renewable energy sectors have not been affected.

Likewise, the DOE continued to scale up the promotion and implementation of energy efficiency and conservation through the roll-out of necessary guidelines, and policies as required by law.

To date, as the country transition to a "new normal" of treating the virus as endemic, like the ordinary flu, the energy sector is also returning to its pre-pandemic level of operations. And while it continues to perform its mandate without undermining the risks and threats posed by the pandemic, construction, operations, and implementation of programs and projects must move forward to help our economy bounce back and grow quickly.

### An opinion released by the Department of Justice states that the renewable sector should be open to full participation by foreign players. How does the DOE view this development and are there measures that will be in place to further attract RE players in the Philippines?

The DOE is pleased with the recent Opinion issued by the Department of Justice that the exploration, development, and utilization of inexhaustible renewable energy sources are not subject to the 60:40 foreign equity limitation as provided under Section 2, Article XII of the Constitution. This means the foreign ownership restrictions that hamper the flow of investments in the renewable energy sector in the country may now be relaxed. However, the DOE must first amend the Implementing Rules and Regulations (IRR) of Republic Act No. 9513 or the Renewable Energy Act of 2008 (RE Act) to conform to the Opinion. We just concluded our virtual consultations for the amendment of the IRR and are now in the process of preparing its draft.

In line with this, we requested from the National Economic Development Authority (NEDA) the exclusion of RE development from the Foreign Investment Negative List.

Meanwhile, to encourage more investors and end-users to develop and utilize domestic energy sources, the DOE has increased the percentage of the utilization of RE for ongrid areas from 1% to 2.52% beginning in 2023. As of June,

with a total installed capacity of 5,460.59 megawatts (MW) and a potential capacity of 61,613.81 MW. Around P270.8 million of investments have flowed into the RE so far with solar investments accounted for nearly half of the total amount at P130.4 million, wind with P52.9 million followed by hydropower with P38.7 million, biomass with P38.2 million, and geothermal with P10.5 million.

The DOE has also granted all generating units utilizing RE resources preferential dispatch in the Wholesale Electricity Spot Market (WESM). This will aid the government in accelerating the development and utilization of indigenous RE resources and reduce the dependence on imported conventional energy sources. This will also minimize the country's exposure to price fluctuations in the global market, making the supply and delivery of electric power more stable and secure from international geopolitical conflicts.

In addition to the implementation of the fiscal and nonfiscal incentives as provided in the RE Act, the DOE also recently conducted the Green Energy Auction for around 2,000 MW capacity to be online starting 2023. The DOE is also directing the transmission network provider to prepare the transmission network for more entry of renewables, such as the Competitive Renewable Energy Zone (CREZ) Program.

### The country's energy efficiency sector has progressed since the implementation of the Energy Efficiency and Conservation (EEC) Act in 2019. What is the Agency's next step in advancing EEC efforts in business, government offices, and even households?

Indeed, the country is making progress in scaling up clean and sustainable energy through the implementation of the EEC Act and its Implementing Rules and Regulations (IRR). This Act boasts the initiatives to institutionalize energy efficiency and conservation as a way of life for all Filipinos.

Following this, the DOE created an Inter-Agency Energy Efficiency and Conservation Committee (IAEEC) to evaluate and approve government energy efficiency projects and provide strategic direction in the implementation of the Government Energy Management Program (GEMP). The GEMP outlines EEC practices enforced in all government offices including local government units (LGUs) to meet the 10 percent reduction in monthly consumption of electricity and petroleum products. As of July 2022, GEMP compliance stands at 56.4 percent, translating to savings of 263 GWh and 113,758 liters in combined diesel and gasoline.

Accordingly, in its effort to lead the way in implementing energy efficiency, the DOE is seeking bids for the conduct of energy efficiency and conservation research and policy study for its existing facilities and infrastructure. The purpose of the technical study is to assess its existing facilities to be in line with the guidelines on the energy conservation design of the building. It also covers the penetration level of energy-efficient technologies in a building under review, including energy conservation measures and best practices adopted and the use of renewable energy technologies intended to manage electricity consumption purchased from the grid.











### **REPH100 Initiative in Support of the Green Energy Option Program**

Inspired by the global RE100 initiative, the REPH100 movement is a private sector-driven effort aimed to support the Green Energy Option Program implemented by the Department of Energy. It adopts a whole-ofsociety approach to fueling the Philippine energy transition for more inclusive economic recovery.

It enjoins the public and private sectors, including The REPH100 Initiative has the following focus areas: policymakers, renewable energy developers and end-Policy Advocacy with focus on supporting the users in encouraging and supporting stakeholders to GEOP and energy transition shift to 100% renewable energy.

The REPH100 Initiative was launched by the ECCP and the National Renewable Energy Board in February 2021. The said virtual gathering was also attended by the Department of Energy and the Energy Regulatory Commission, as well as supporters from the private sector composed of renewable energy suppliers and ECCP members whose global operations have joined the RE100 movement.

### What is the Green Energy Option Program (GEOP)?

- GEOP is a voluntary policy mechanism that provides electricity end-users with 100kW and above demand the option to choose RE resources as their source of energy.
- GEOP is a non-regulated activity.
- It provides options to end-users to contribute in the development and utilization of RE resources in a least-cost and sustainable manner.
- RE Suppliers must secure an Operating Permit from the DOE.


### **HR Management Series** 29 September, 18 October 2022



The Secretary also shared the Department's plans and priorities for the next years including food security, water security, and waste management among others. Possible areas for collaboration between the DENR and the ECCP were also discussed during the meeting.

### RE&EE and REPH100 Meeting with DOE **Assistant Secretary Mylene Capongcol** 20 October 2022

Last 20 October, the ECCP organized a hybrid meeting with Department of Energy Assistant Secretary Mylene Capongcol. The group talked about various policy developments in the energy sector, with focus on the renewable energy scenario in the Philippines. As a focus area of the Chamber's REPH100 initiative, the attendees also provided their insights and bottlenecks in transitioning to increased use of renewable energy in their operations. Among those represented at the meeting were companies from the energy, manufacturing, and water sectors, as well as Embassies. The meeting was also attended by Directors Marissa Cerezo and Michael Sinocruz.

### Virtual Public Consultation on the Draft Circular Prescribing Amendments to Section 19 of Department Circular No. 2009-05-008 24 October 2022

The ECCP was represented at the DOE Virtual Public Consultation on the Draft Circular prescribing amendments to the Implementing Rules and Regulations of the Renewable Energy Act of 2008. The draft circular seeks to lift the foreign participation limitation in the extraction, distribution, and utilization of solar, wind, and ocean renewable energy sources. The ECCP, together with the Joint Foreign Chambers of the Philippines (JFC), have advocated for the relaxation of foreign equity limitations in the renewable energy sector in various engagements with policymakers and industry players. The ECCP welcomes this development as we strongly believe that opening up the RE sector will maximize the Philippines' potential to attract more foreign players, and support the country's energy transition and sustainability goals.

### **ECCP Courtesy Meeting with BSP Governor Felipe Medalla**


