The Philippines adopts a 'first-to-file' patent system, meaning that the first person to file a patent in the jurisdiction of the Philippines will own that right within the country once the application is granted. The Philippines also allows utility model registrations for an invention with lesser degree of inventiveness. The process for obtaining a utility model is shorter, however, there is a reduced term of protection – as patents are protected for 20 years after filing whilst utility models are only protected for 10 years after filing. Utility models should nevertheless be considered by the eco and green technologies companies, as a lot of technology these companies produce consists of improved versions of the technology already in use. Finally, combining utility models with invention patents can also be a smart way to deal with environmental technologies based on legacy technology.

Once the patent has been granted, SMEs should keep in mind to always indicate the wording as "Philippine Patent No." or "*Philippine Patent Pending*" on their products. This is to establish the presumption that the infringer had known about the existence of the patent. Otherwise, damages may not be recovered for acts of infringement if the infringer shows that he/she has not known or had no reasonable grounds to know that there exists a patent for this product.

#### PATENTS ARE THE CORNERSTONE FOR HIGH-TECH COMPANIES

protection available for high-tech companies active in the environmental technologies sector. This is because many eco and green technologies are highly capital-intensive and take a long time to achieve market acceptance, especially for those that are currently too expensive to be commercially viable. Besides technology, SMEs can also patent business methods relating to environmental sector, such as Fannie Mae's patent for "System and method for residential emissions trading", which is a method for identifying, quantifying, and aggregating reductions in residential emissions into a tradable commodity.

A patent confers its owner the exclusive right to restrain, prohibit and prevent any unauthorized person or entity from making, using, offering for sale, selling or importing the patented product, thus European SMEs active in environmental technologies sector should consider applying for patents in the Philippines to protect their products from being copied.

At the same time owners of well-known marks may benefit from the Philippines membership to the Paris Convention. Foreign nationals may request the refusal or cancellation of a registration of a trade mark which constitutes a reproduction, imitation or translation of a well-known mark in another country that is also a member of the Convention.

If an SME builds a reputation for being prompt and reactive, then unscrupulous companies will be less likely to infringe its rights in the future.

In the Philippines, there are three avenues to enforce intellectual property rights: administrative actions, civil litigation and criminal prosecution. As civil litigation and criminal prosecution tend to take longer time and become costly, administrative actions are often the preferred means of enforcement for SMEs. Administrative authorities have the power to impose preliminary injunctions, preliminary attachments (a provisional remedy wherein the court/ administrative body is asked to take custody of the property of the adverse party as security for satisfaction of any judgment) as well as damages and administrative fines. In many cases, however, negotiations or mediation between the parties can be a more viable option as they are cost effective.

Individual SMEs and SME intermediaries can submit their IPR gueries via email (guestion@southeastasia-iprhelpdesk.eu) and gain access to a panel of experts, in order to receive free and confidential firstline advice within 3 working days.

## **Philippines initiates ASEAN disaster risk** management database to combat climate change

As announced by the Department of Finance (DOF), the Philippines urges fellow members of the Association of Southeast Asian Nations (ASEAN) to create a region-wide database on disaster risk management.

The region-wide database on disaster risk management among the ASEAN proposed by the Philippines would allow the sharing of information on mitigating the effects of climate change and guarantee timely assistance during calamities.

DOF Secretary Carlos Dominguez III mentioned that the Philippines is spearheading the proposal by communicating

times of catastrophes and other crises even though there are "existing capacity constraints".

During a recent joint meeting in Singapore, Sec Dominguez, his fellow finance ministers and the central bank governors in the ASEAN stressed the significance of strengthening their countries' resilience in facing calamities.

The ASEAN Finance Ministers and Central Bank Governors. in a joint statement after the 4th ASEAN Finance Ministers' and Central Bank Governors' Meeting, said that the resilience of its member-states "is important for sustaining growth as well as protecting our people's well-being."

Moreover, "We note the ongoing ASEAN Disaster Financing and Insurance (ADRFI) initiatives to enhance the region's capacity to adopt and implement ex-ante and ex-post disaster risk management measures. Cambodia, Laos and Myanmar are working together to launch the Southeast Asia Disaster Risk Insurance Facility (SEADRIF) as a disaster risk management solution for the region."

Sec Dominguez said that an urgent need to implement disaster risk management measures to protect the country's vulnerable communities against climate change is brought

He added, as stated in the joint statement, the regional bloc has already initiated a program to coordinate the sharing of disaster risk financing, with its first phase completed in June 2017.

Funding support for the region wide disaster risk insurance facility will come from the German development institutions GIZ and KfW. This initiative is "a pioneering ASEAN project that could be adopted in other parts of the world," Dominguez explained.

"The countries of this region are stepping up to the challenges facing us today. The ASEAN itself has become a mechanism for disaster risk mitigation on a broader level. This is as it should be," he noted.

#### **ECCP Coffee Mornings**

Birgit Hansl, World Bank's Lead Economist for East Asia and the Pacific, discussed the most recent economic changes and developments in the Philippine context as of April 2018. Present findings show that while the projected growth rate is at 6.7%, high inflation rates, increasing fiscal deficits, and economic overheating pose a medium-term risk. The sector's most pertinent challenge then, is not solely the mobilisation of investments, but also the assurance that the resulting projects are productive or revenuegenerating. Moreover, Ms Hansl emphasised that these economic insecurities could be overcome by state policies that open more investment opportunities in the country for different value chains. This includes the generation of quality jobs, changes in the regulation and competition of business entities, and a faster real wage growth which has been significantly flat over the past decade.

#### **Unfazed: It's Business as Usual**

About three decades ago, the Davao Region was not as highly attractive for investments as it is now. Back then, the opportunities for investment and livelihood were limited to agriculture and its related industries.
