She is responsible for leading the planning, supervision and implementation of collection enforcement actions for both civil and criminal tax cases. Chief Lacerna has served in various enforcement capacities – as tax examiner to lead investigator, policy maker, process reengineer, trainer, resource speaker, and change mover.
